The 1990s: Building a New Scotland

- The NHS and Community Care Act 1990
- The Princess Royal Trust for Carers
- 1994: First Carer Centres in Scotland
- Campaign for a Scottish Parliament & The Constitutional Convention – reflecting a very inclusive approach
- 1997 Referendum, The Scotland Act 1998
- 1998 the Coalition of Carers in Scotland born
- 1999 The Scottish Parliament in 1999





1999 – 2009 Carer Recognition

- 1st Scotland Carers Strategy Nov 1999, Iain Gray
- The Adults with Incapacity (Scotland) Act 2000
- The Community Care and Health Act 2002
 recognises carers as 'Partners in Care', NHS Carer Info Strategies,
 carers assessment and Free Personal Care for older people
- 2005: 'The Future of Unpaid Care in Scotland'
- The network of Carer Centres grows, Coalition of Carer gets funding and appoints first staff member
- 2009: Caring Together, Carers Strategy for Scotland'

2009 – 2018 From Recognition to Rights

- o 2012 first Carers Parliament
- Carers (Scotland) Act 2016, Implemented 2018
 Rights include:
 - The right to information and advice
 - A right to an Adult Carer Support Plan, or Young Carer Statement
 - The right to be consulted on services and involved in the hospital discharge
 - o The right to support where they meet eligibility criteria

The 5 National Carer Organisations form a closer partnership

The Public Bodies Joint Working Act becomes law in 2016 and carers become members of the Integrated Joint Boards



From recognition to rights

2018 - 2023

- Free personal care is extended to all adults (2020)
- The pandemic has a huge impact on carers
- Independent Review of Adult Social Care in Scotland (2021)
 recommends radical changes to improve social care in Scotland
- Proposals for a National Care Service, incl a right to breaks from caring
- The Scotland Carers Strategy published in December 2022



The secrets of success

- Always aspirational and carer-led
- First and foremost an advocacy movement the voice of carers
- Clear aims and principles, based on guiding principles of Eurocarers
- o Framing the debate on our terms:
 - o 'unpaid carers', not informal carers
 - o 'equal partners in care'
- Solution-focused
- Building alliances engaging a wide range of partners
- Co-operation, collaboration and co-production
