- Referrals to local carer
   organisations increased by an
   average of 41% with more
   complex issues and carers in
   crisis.
- 42% of local carer organisations reported being on one year funding cycle.

"Whilst the number of new referrals has gone up, we are also still supporting carers registered in previous years. We will have contact with around half of these during the year"


#### Increased National Insurance Contributions



from recognition to rights

- Anticipated cost to carers centres
  almost £400k in year one.
- Variation of £1172 up to almost £100k 64% organisations are planning to use their reserves in year one.
- 96% of respondents said reported an impact on sustainability, with 36% reporting a substantial risk.

"This will have a crippling effect on our plans for the service at a time when demand is rapidly increasing."





from recognition to rights

- 1 in 3 carers centres received a cut to their funding
- 17% received an increase in funding.
- 50% received standstill funding
- The range of cuts was 2% to 20%

### False Economy

"We are stopping Young Carer Time Out groups and closing our phones on a Friday afternoon as we don't have capacity to cover.

Frankly we are at breaking point.

We support around 1400 carers each year. Carers save an average of £22,000. If just 3 carers stop caring, it will wipe the savings the local authority have made"
